Why Go Solar in Virginia?

And here's something California doesn't offer: Storm resiliency rebates. Virginia's new Grid Security Initiative

gives bonus incentives for battery storage installations. After last year's nor'easter outages, this program's popularity skyrocketed 300%.

Installation Tips from Industry Pros

"Always get three quotes," advises Sarah Mitchell, a solar consultant in Norfolk. "But more importantly, check if installers understand Dominion's interconnection requirements. I've seen systems delayed six months over paperwork glitches."

Pro tip: Schedule installations between February-April. Contractors aren't swamped yet, and you'll beat the summer rush. Just avoid starting projects in November - holiday breaks and winter light conditions can stretch timelines.

Quick Questions Answered

Q: Can renters access Dominion solar incentives?

A: Absolutely! The Community Solar program requires no property ownership. Over 1,200 apartment dwellers in Arlington joined last quarter.

Q: How does Virginia compare to Maryland's solar programs?

A: Maryland offers higher tax credits (30% vs VA's 26%), but Dominion's SREC market pays better long-term returns.

Q: Do solar panels increase Virginia property taxes?

A: Nope! The state's Solar Energy Equipment Exemption law prevents tax hikes for residential systems under 25kW.
