## How Florida Stacks Up Against Texas and California

While California's NEM 3.0 policy slashed solar savings, Florida's net metering survived political drama--for now. Texas offers similar rebates but lacks Florida's sales tax exemption on equipment. Bottom line? The Sunshine State's combo of solar incentives and high electricity rates (12.21¢/kWh vs. national 10.54¢) creates a 7-year average payback period--faster than 32 other states.

## Burning Questions About Florida Solar Rebates

Q: Can I combine federal and Florida-specific rebates?

A: Absolutely--they're designed to stack. The 30% federal tax credit applies after state/local discounts.

Q: Do rebates cover solar panel repairs?

A: Generally no, but some installers offer rebate-protected warranty upgrades.

Q: How long do applications take?

A: Most Florida utilities process rebates in 6-8 weeks--faster than California's 12-week nightmare.

Q: Are there income limits?

A: Only for specific programs like LIHEAP. Most solar rebates are income-blind.
